- 1. Do you think that the protection of Narrabeen Lagoon Catchment is a high priority for the region? How valuable is biodiversity in this area? Do you think environmental protection should be retained as a key land use objective for non-urban land in Narrabeen Lagoon Catchment?' *Friends* have supported the E2 (environment protection) zone e.g. for core bushland, rather than the E3 (environmental management) zone. In bushland areas where no development should occur, the E2 zone is preferable to the standard zone translation of E3.
