

Forum 4: Creating a Sustainable Catchment

It's time to have your say: work is at last about to get underway to remediate the key feeder creeks leading into Narrabeen Lagoon. James Brisebois, the council officer overseeing the project, will explain exactly how the \$1.9m grant secured at the instigation of *Friends of Narrabeen Lagoon Catchment* is to be spent. Middle, Nareen and Mullet Creeks are polluted by siltation, their embankments an impenetrable mass of exotic weeds, including bamboo, morning glory and lantana. However, the most invasive weed of all, particularly along Middle Creek is Ludwigia. Weed mapping for Middle Creek has been completed and these maps will be presented at the Forum. A separate grant has been secured for Deep Creek.

State Member for Wakehurst, Brad Hazzard will present his perspective on the need for catchment protection and remediation.

During the evening you will also be brought up to date with other actions *Friends* is undertaking in the catchment. The meeting is open to members and non-members.



Dept of Lands ignores their Minister

In October 2007, Minister Kelly in Parliament stated in relation to land in the Oxford Falls Crown Reserve, that **"No action will be taken over these lands pending the finalisation of this review by way of a plan of management"**. The tender has not yet been let to prepare this Plan of Management and yet Greg Foster of Dept of Lands advertised in the Manly Daily on April 10, the degazettal, then sale or lease of one portion of this Reserve. At our suggestion Brad Hazzard has undertaken to write to Minister Kelly and *Friends* has sent letters to Premier lemma, Minister Kelly and the media.

Action taken on many fronts

The price of democracy is eternal vigilance! Your committee takes this to heart. On March 3, we were invited to attend a pivotal meeting instigated by local member Rob Stokes with other MPs and decision makers in councils, concerning the completion of the path around the lagoon through land occupied by the Academy of Sport.

We have also on your behalf prepared submissions, made suggestions and attended meetings on the Plan of Management for South Creek, Pittwater's 2020 Strategy, Action Plans for Nareen and Mullet Creeks and the Plan of Management for Bilarong Reserve. We have been unsuccessful in lobbying Warringah Council to notify us of Development Applications that could impact the catchment. This is an important aspect of transparency, which Council claims to espouse. *Friends* has representatives on the Project Reference Group for the \$1.9m Government Grant Catchment Project. The group meets this week to monitor progress and ensure set milestones are being achieved. It's an important role for us. We also salute active *Friends* member Owen Spencer, who has proposed starting a catchment monitoring programme to collect and collate data on the effect the rehabilitation programme has on the water, flora and fauna. Bad decisions impact bushland

Wheeler Creek Valley retirement villages (Maybrook Village and Willandra Bungalows) were both built close to their boundaries without allowance for bushfire via Asset Protection Zones (APZ) in their properties, even though the need for this was clearly understood at the time. Remember the 1994 bushfires that swept through the catchment? This month Maybrook Village, through the Land & Environment Court, gained permission to build a further extension even closer to the bush, by modifying bushland in Oxford Falls Crown Reserve and on Warringah Council land as their APZ. A bad ruling from 1985 (about which Department of Lands was unaware) was quoted as the justification for this.
