Good progress on \$1.9m grant restoration

Three years ago *Friends* was instrumental in securing a \$1.9m Heritage Trust grant to restore the creeks leading into the lagoon. Since August of last year, both Warringah and Pittwater Councils have had bush regeneration contractors working at sites along Middle Creek, the Nareen Creek wetlands, Kundibah Reserve, the middle reaches of Mullet Creek and Irrawong Reserve.

Project Officer James Brisebois reports that work for the last 12months has been focused on severing exotic vines, clearing lantana from native canopy trees and maintaining buffer zones to allow natives to revegetate. All *Ludwidgia peruviana* (Primrose Willow) and Pampas Grass growing in the creek lines and swamp areas have been removed. Areas of resilient bush and good bushland core areas are being maintained and expanded. Sections of good bush are being linked to others by revegetating and regenerating. Areas which prove to be the most resilient or less prone to weed reinfestation are being identified.



Weed free and healthy

Maintenance work will continue and additional funds will be allocated to bush regeneration in the upper portions of Middle Creek and the Nareen Wetlands, Oxford Creek and Deep Creek. A Project Review Group monitors progress. *Friends* has three representatives on that committee – Judith Bennett, David Palmer and Tony Carr.

Behind the scenes ...

Our mission is to see the remaining bushland in the catchment of Narrabeen Lagoon permanently protected. The problem is that there are constant pressures to replace bushland with urban development.

So far this year your committee has written submissions or lobbied decision makers on 15 issues - that's two a month on average!

The issues include proposals for three different retirement villages, including the \$100m Sid Londish resort proposal for Oxford Falls, various plans of management, the misallocation of funds from Crown Land sales, water quality degradation, the Koi fish farm proposal, various issues relating to planning, biodiversity and climate change, adverse recreational impacts in Garigal National Park and the urgent need for the State Government to make good on Bob Debus' 2005 promise to protect forever the 446ha of Crown Land in the Narrabeen Lagoon Catchment.

Friends thanks Committee member Ann Sharp, who works tirelessly behind the scenes on many of these issues.
